



JAMES B. WARNER SCHOLARSHIP FUND APPLICATION FORM

The James B. Warner Scholarship was created by James B. Warner to encourage young professionals to seek higher education in a water-related field. James B. Warner served the Rocky Mountain Section for years in various leadership roles, including mentoring and encouraging young people. The scholarship is for \$2,000 and is given annually by RMSAWWA.

Criteria for candidates include:

- The applicant must be a member or dependent of a member of the RMSAWWA.
- The applicant must be a student who will be at least a junior in the next fall term, pursuing a degree at an accredited college or university.
- The fields of study applicable for the scholarship include, but are not limited to: water, water utility management, and water resources.
- Funds may be used for tuition, books, or fees. The RMSAWWA section will administer the funds.
- Application deadline is July 1st of each calendar year.

INSTRUCTIONS: All blanks must be completed for Award eligibility, additional sheets may be attached if needed.
